Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 5 (total in Bal Vatika I, II & III). The total number of sections of the school from class I to X shall be restricted to 31. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has converted regular cubicles into CWSN toilets which are too small and narrow and there is no room for a wheelchair/walker to navigate. Signage is temporary. The grab bars are not available. CWSN toilets are not seen on all the floors. Thus the school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography.
3	The school does not have RAMP to access the upper floor. Hence the school is directed to construct the ramp so as to make it CWSN friendly or to install the lift within 3 months and submit compliance on SARAS with videography.
4	The composite lab is not properly laid out. It does not have separate work station (with reagent shelves) for chemistry and (without shelves) for bio sections. There is no lab standard table for Physics section and its equipment is seen placed on side slabs which is not conducive for conducting experiments. No safety mmeasures are seen. The school shall set up the composite lab as per SoPs issued by the board within 3months and submit compliance on SARAS with videography.
5	The school shall renew Building Safety, Water and Sanitation Certificates immediately (suggestive format is available with Circular no 12/2022) and upload on mandatory public disclosure section on Home Page at the school website within 3 months and submit compliance on SARAS.
6 T	The math lab seems to be a temporary arrangement with tables joined together with no seating and storage facility. It is also under stocked as very basic equipment(geometric shapes) only are seen. The school shall upgrade its math lab as per SoP issued by the Board within 3months and submit compliance on SARAS with videography and a storage and storage and submit compliance on SARAS with videography.
1001: 100	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- The approval is based upon the documents /data/information uploaded by the school online. The school will 1. be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT 2. Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School is required to apply on online for extension of affiliation along with the requisite fee and other 3. documents as per Rule 10.3 of Affiliation Bye Laws.
- The school should go through the provision of Affiliation and Examination Bye Laws and subsequent 4. amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school 6. name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- The school shall not remove the documents and videography links in the mandatory disclosure section of its 7. website.
- The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the 8. Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
